

haratiya Vidya Bhavan (BVB) was established by legendary writer, statesman and academician Kulapati Dr. Kanaiyalal Maneklal Munshi in 1938, in Mumbai. The idea was to promote educational and professional training with the values, virtues and the culture of India. Bharatiya Vidya Bhavan (popularly known as Bhavans) was founded on Kartik Sud Purnima, Samvat 1995 (November 7, 1938), almost a decade before the advent of India's Independence - with the blessings of Mahatma Gandhi.

Bhavans is a charitable public trust, dedicated to the promotion of Education, Art and Culture. In his inaugural address of Bhavans, Shri Munshiji said,

"For many years it had been the dream of the Sahitya Sansad to crystallize its work, by creating a centre in which the ancient learning and modern intellectual aspirations of this land could combine to create a new literature, a new culture. The Bhavan will be a new association which will organise active centres where ancient Aryan learning can be studied and where modern Indian culture will be provided with a historical back-ground."

Today, Bharatiya Vidya Bhavan is a very well-known institution with a large number of colleges, schools, cultural centres, and other institutions within and outside of India. Through these institutions, it makes a significant contribution to the academic, cultural, and social development of the entire nation.

The Bhavan provides education in a variety of subjects, including Arts, Science, Commerce, Engineering, Modern Management, Mass Communication, Information Technology. Even in foreign languages like French, Spanish, Russian, German, and Japanese, through its numerous schools, colleges and institutes dispersed throughout India. They range from kindergarten to postgraduate and research levels. Additionally, they also promote National Integration and Communal Harmony, Purity in Public Life and Rural Regeneration.

The Bhavans is registered under the Societies Registration Act XXI of 1860 and the Bombay Public Trust Act of 1950. Bhavan's has 367 constituent institutions, 119 kendras (branches) in India and 6 centres abroad.

# RPICM An Introduction

ajendra Prasad Institute of Communication & Management (RPICM) is a flagship of Bharatiya Vidya Bhavan's educational initiatives, for skilling and upskilling, students and professionals. It started in 1961, as Bhavan's College of Journalism, Advertising and Printing in Mumbai. The Institute gained popularity amongst lakhs of its alumni across India in the last six decades, for pioneering courses that are very useful for working professionals and students alike.

It was renamed as Rajendra Prasad Institute of Communication Studies in 1965, in honour of Dr. Rajendra Prasad, the first President of India and also one of the founders of Bharatiya Vidya Bhavan.

It emerged as easily the largest network of institutes, providing journalism, communication and media education in India, through its centres spread across several states.

It was in 1978, that its activities and scope were widened with the introduction of management education in its mandate. Thus, it got renamed as Rajendra Prasad Institute of Communication and Management (RPICM).

Today, it offers multiple courses to learn professional skills in communication and management areas. It is also famous for making available professional skills based courses to employed individuals or students pursuing other studies, who want to upgrade their skills, but can't do that in working hours. RPICM pioneered, evening and part-time programmes in professional skills area.

Bharatiya Vidya Bhavan's courses have emerged as a benchmark for many other colleges, institutes and universities to replicate their success. Some of the courses also enjoy the privilege of being recognised or equated as diploma courses, by multiple universities. Many of the courses have been officially notified by the central and the state governments, as a qualification for several positions in government departments.

Several generations of successful journalists, editors, public relations professionals, corporate communication experts, HR managers, foreign trade experts, government officials and professionals from many other fields owe their success, to the skills learnt at Bhavan's RPICM.

# **General Guidelines**

# I. Eligibility

- 1.1 Candidates seeking admission to Post-Graduate Diploma Programmes in Communication or Management must have successfully completed an under graduate degree course (Graduation) from a University/Institution recognised by the University Grants Commission. Or they should be studying in the final year and are scheduled to appear for the final exams.
- 1.2. Any deviation in the prescribed Eligibility Rules under Para 1.1 should be first referred to RPICM by the intending student, ascertaining his/her eligibility for seeking admission to the courses. Such students are advised not to take admission unless their eligibility in such cases, has been confirmed by the RPICM.
- 1.3. There are courses or components of some of the courses, which are open for admissions, for non-graduate students, as certificate courses. There are separate courses for High School students as well.

# 2. Application For Admissions

- 2.1. The application for admission to the College as well as for enrolment in the Rajendra Prasad Institute of Communication and Management must be submitted in the prescribed forms to the Principal/Director of the College concerned on or before the prescribed date as notified.
- 2.2. These applications must be accompanied by copies of the Marks Certificates, and the passing certificate of the qualifying examination issued by the recognised University or its constituent college and valid ID proof (Aadhar card, Pan Card, Driving Licence and so on).
- 2.3. The latest copy of a passport size photograph should be affixed on the form, with the signature of the student concerned on each of them.
- 2.4. Prescribed fees should be paid at the time of the form submission.
- 2.5. It is the responsibility of the candidate to satisfy himself/herself that he/she conforms to the eligibility norms prescribed by the RPICM.
- 2.6. The management of the college and the RPICM reserve their right to reject any application, without any explanation, at any time. Also, if found incomplete and the information provided by the candidate deemed incorrect.
- 2.7. All admissions would be considered as provisional till such time their enrolment is confirmed by the RPICM.
- 2.8. Candidate desirous of changing their Post-Graduate Diploma Programme from one group to another, will be permitted to do so on submission of an application, addressed to the centre co-ordinator within one month from the date of commencement of classes, subject to fulfilment of all conditions. However, such an approval will be subject to discretionary approval by the head of the concerned institute.
- 2.9. In the event of dispute of any sort, between the candidate, the RPICM and/or the Bharatiya Vidya Bhavan, the courts in Mumbai alone shall have the jurisdiction and their decrees are legally binding on all concerned.

### 3. Medium of Instruction

- 3.1. The medium of instruction for all Programmes being conducted by the RPICM Centres or affiliate colleges, shall be English, unless specified by them for a particular course.
- 3.2. The students opting for language Journalism or some of the courses with an option of language, might still continue to receive theoretical instructions in the form of lectures, through the medium of English.
- 3.3. Their practical classes in respect of subjects such as editing, reporting, writing etc. may be conducted by well-known expert journalists, in the particular language (regional language) for the benefit of those candidates.

# 4. Academic Year

- 4.1. Students will be evaluated based on Internal Exams and External exam. External exam will be conducted by RPICM and is equally applicable to all centres.
- 4.2. Each constituent college is autonomous in conducting Internal Exams according to the examination patterns suggested by RPICM.
- 4.3. Dates of commencement and conclusion of internal exams may vary slightly in different parts of India subject to local conditions and requirements.
- 4.4. Unless specified in the syllabus, the maximum number of contact hours for the entire duration of any course will range from 150 to 170 hours.
- 4.4. Of these, 150 hours will be spent in class-room teaching, with the remaining to be spent on practicals and hands-on guided training sessions.

# 5. Examinations and Eligibility for taking one

- 5.1. In order to help students stay focussed on learning and for the purpose of assessing their skills in a particular subject, RPICM will be conducting internal and external exams during the period of most courses.
- 5.2. Marks from both internal and external the exams will be considered to arrive at an average of performance, which will make the basis for grading. The passing certificate will not be issued until the students have cleared exams of all the subjects in both exams.
- 5.3. Please note that marks for internship, training, project submissions, assignments, viva voce exams, class-work etc will be a part of the total marks used to calculate performance in the final exams and for overall grading.
- 5.4. Each student must have a minimum of 75% attendance (per subject) in order to be considered qualified to appear for the external exam.
- 5.5. A student having attendance between 65% to 75% will need written approval from Centre Coordinator for appearing in the examination.
- 5.6. Students with less than 65% attendance will be declared debarred, and he/ she will have to pay debarred fee at the time of filling up the Examination form if the student is allowed to keep the term.

- 5.7. The Centre Coordinator with approval of RPICM, may condone the shortage of attendance for valid reasons to be recorded, on payment of debarment fees.
- 5.8. The examination pattern will be a mix of continuous evaluation with written exams. The External exams will comprise short, brief and descriptive questions.

# 6. Examination Applications

- 6.1. Any eligible candidate whose enrolment is confirmed by the RPICM intending to appear for the Examination; must submit without fail his/her application in the prescribed form with a passport sized photograph affixed on it, and duly signed by him/her.
- 6.2. Incomplete applications will be summarily rejected. Such applications, complete in all respects, and accompanied by cash or bank draft or online payment receipt for the requisite fees, must be submitted without fail on or before the fixed date.
- 6.3. This period may be extended, at the discretion of the Centre Coordinator, by another 15 days, but with a late fee.
- 6.4. Applications not routed through the Centre Coordinator or not duly endorsed by him/her, will not be accepted by the RPICM.
- 6.5. Correspondence, if any, by the candidates, with the RPICM shall invariably be through the Centre Coordinator.
- 6.6. The Centre Coordinator will notify, well in advance, of the last date fixed by them for submission of examination applications. Such a notification placed on the College Website or Notice Board or shared through an official email shall be deemed to be a public notice.
- 6.7. Candidates must clearly specify the paper(s) chosen for the Examination, where there are optional papers or sections as a choice. The choice of an optional paper or section should also be clearly mentioned, along with medium of answer.

# 7. Withdrawal of Examination Applications

- 7.1. Where a candidate has paid the examination fee, and submitted the application, he or she will not normally be allowed to withdraw from the examination, and the examination fees are not refundable.
- 7.2. The Centre Coordinator can withdraw the examination application of a student: a. if the student fails to fulfil the requirements of minimum attendance.

b. if the student does not take internal examinations on time.

# 8. Change of Examination Centre

- 8.1. A candidate who wishes to appear for exams at a centre other than where the admission was granted, he or she has to seek permission from the RPICM before submitting the examination application form, through the Centre Coordinator.
- 8.2. Permission for transfer or change of Examination Centre will be granted, only if the desired Centre is conducting such an exam.

# 9. Supplementary Examination

- 9.1. Supplementary (re-sit) Examination will be conducted for candidates who have not been able to attend the regular examination and/or who have not secured the minimum marks required for passing, in a particular examination.
- 9.2. In case, the RPICM revises its syllabus of a particular course, the student will have to clear the supplementary(re-sit) exams in two years, in the old syllabus. After that, it will be offered in the new syllabus.

# 10. Disciplinary Action For Misconduct And Use Of Malpractice In Examinations

- 10.1. The candidate shall be deemed to have used unfair means if he/she is found:
  - a. in possession of copying material, either handwritten, typed or printed or by any other means.
  - b. communicating or attempting to communicate either directly or indirectly with any other candidate/s or any other person concerned with the examination, with the objective of influencing him/her in any way.
  - c. to have copied the answer/s either from some other candidate or from any other source, including mobile phones and other electronic gadgets.
  - d. using abusive language or making derogatory remarks in the answer book.
  - e. to have been impersonated.
  - f. smuggling of answer books and forging signature of Block Invigilator.
- 10.2. A candidate who indulges in any unfair means/practices during the Internal Assessment or End Semester Examination will be liable for disciplinary action. RPICM will treat the performance of the whole examination as null & void and the candidate will be debarred from appearing in the subsequent examinations, or any examination of any programme, any time, depending upon the degree of severity of the offence.
- 10.3. The RPICM is the final authority to decide the penal action for the use of malpractice in examination on receipt of the report along with the relevant documents of the Unfair Means Inquiry Committee of the concerned Centre.

### 11. Marks Certificates

- 11.1. On the basis of the marks prepared by the RPICM, copies of individual marks certificate will be issued to the candidates, through the respective Centre/Affiliate College where admission was taken.
- 11.2. The RPICM issues Mark Certificate to both Pass and/or Fail Candidates, who appear in the examination. This includes those who appear with exemption in some of the subjects.

# 12. Verification of Marks and Re-evaluation of Answer scripts

- 12.1. Verification of total marks in a subject is not re-evaluation of the answer-book. In case the student is not satisfied with the marks obtained by him or her in any paper(s), the student is advised to apply for verification.
- 12.2. In verification, an endeavour would be made to verify whether all the answers have been assessed and assigned marks. If any answer is left out unassessed or the marks need to be revised, it will be assessed and assigned marks, which shall be added in the grand total accordingly. Thus, it includes re-totaling of marks question-wise and grand total only.
- 12.3. If a student is not satisfied with the marks in any paper(s), as in the results announced and the mark certificates provided in respect of any Examination, he or she may apply in writing, for verification of the total marks recorded (not re-evaluation) in the answer scripts of such paper or papers
- 12.4. If after this step, in case the student is still not satisfied with the marks obtained by him or her in any of the paper(s), he or she may apply for re-evaluation of the answer-book.
- 12.5. In re-evaluation, the answer-book of the concerned paper will be evaluated afresh. Marks will be assigned based on the fresh evaluation and in the event of an upward or downward revision, the same shall be incorporated in the revised statement of marks.

# UNDER NO CIRCUMSTANCES WILL THE STUDENT BE GIVEN DETAILS OF THE ASSESSMENT OR SHOWN THE EVALUATED ANSWERSCRIPT.

- 12.6. Such applications must be routed through the Centre Coordinator, where the candidate studied, and must be accompanied by payment of re-evaluation fees as stipulated by the RPICM.
- 12.7. The fees charged for verification and/or re-evaluation once paid are not refundable.
- 12.8. It is important to note that application for verification and/or re-evaluation, shall be made within one month from the date of declaration of the results. Late applications will not be entertained.
- 12.9. The result of verification and/or re-evaluation, as intimated by the RPICM, is final and legally binding and no further correspondence will be entertained in that respect.
- 12.10. The application for this must be in writing and must state:
  - a. Name and address of the candidate
  - b. Examination Reg. No./ Enrolment No
  - c. Programme chosen by the candidate

d. The name and number of the paper/s for which (verification/ re-evaluation) has been applied for

### 13. Name of the candidate on record

- 13.1. The name of the candidate on the records of RPICM shall be exactly the same as approved in his or her Enrolment Application, including the spelling and format of the name.
- 13.2. Hence, while filling the examination application, candidates are requested to write their name legibly and in block letters, as approved in their enrolment application. This name will only appear in official documents and certificates. No subsequent name change requests will be entertained by the Institute.

# 14. Holidays

- 14.1. The Centre will be normally closed on public holidays, as notified by the respective state governments, in whose territorial jurisdiction the colleges are situated.
- 14.2. But granting of holiday or change in the day-date of the holiday will be at the discretion of the Centre Coordinator. It will be done keeping in mind the total number of academic contact days to make sure that the academic calendar does not fall short of the specified teaching hours for the course.

# Awards and Scholarships

- 1. The RPICM will honor the prestigious 'KULAPATI AWARD' comprising medals, certificate of academic merit and distinction scholarship at all India level for the best-performing student at the final result.
- 2. The final result will be calculated based on the marks obtained by the students in both Internal and External Examination.
- 3. RPICM will honor the **CENTRE WISE** rank holders of the constituent and affiliated college in particular subjects with gold medals and merit certificates after the declaration of results. **HARILAL BHAGWATI GOLD MEDAL** and merit certificate will be awarded to the Rank holders of Ahmedabad Kendra.

With reference to the letter No.Acad/04/AC-II/2373 dated 29.05.04 the meeting of the Equivalence Committee appointed by the Vice-Chancellor was held on 19.06.04 at 10.30 AM in the Office of the Dean, Media Studies. The following were present:

# The following was decided:

- 1. The syllabus of P. G. Diploma in Public Relations of Bharatiya Vidya Bhavan was also examined in detail and it was found that deficiency of absence of the content of the Human Communication has been rectified by including the full paper on Human Communication. The content of the added paper is adopted fully from the paper of Human Communication of P. G. Diploma in Mass Communication of Guru Jambheshwar University.
  - In view of the above observation, it is recommended that the P. G. Diploma in Public Relations of Bharatiya Vidya Bhavan be treated as equivalent to P. G. Diploma in Mass Communication of Guru Jambheshwar University, Hisar from the session 2004-05 onwards.
- 2. The amended syllabus of the P. G. Diploma in Journalism of the Bharatiya Vidya Bhavan was examined in detail from its Prospectus 2004-05. It was observed that an additional Paper-V Communication has been added as an option to the Paper-V of Newspaper Management & Printing. The entire course content of the Human Communication of PGDMC of Guru Jambheshwar University has been adopted.
  - In view of the above, it is recommended that students of Bharatiya Vidya Bhavan who qualify P. G. Diploma in Journalism from Bharatiya Vidya Bhavan with an option in Human Communication during and after 2004-05 be treated as having qualifications equivalent to P. G. Diploma in Mass Communication of the Guru Jambheshwar University, Hisar.
- 3. For the year 2004-05 the students passing from Bharatiya Vidya Bhavan in 2003-04 and before, the previous arrangement should continue.
- 4. As per the previous decision, the students passing the P. G. Diploma in Mass Communication from Bharatiya Vidya Bhavan will be treated as equivalent to P. G. Diploma in Mass Communication of Guru Jambheshwar University, Hisar. All the topics of the Syllabus of P. G. Diploma in Mass Communication of GJU are in the syllabus of P. G. Diploma in Mass Communication of the Bharatiya Vidya Bhavan.


